It was decided to examine whether hiring of private staff car is necessary through a tour operator and Members may be provided convenient mode of transport befitting their status and as per functional requirement. **(Action: Genl. Section)**

Following suggestions were given and approved for incorporation in the report on strengthening of NCSC-

- (i) Draft Constitutional amendment for NCSC recommendations to be mandatory should be enclosed with the report.
- (ii) Status of Members of NCSC (Presently equivalent to Secretary) may be considered to be upgraded to that of MoS similar to provisions in National Disaster Management Authority. **[Action: Consultant]**

It was decided that a final view by NCSC would be taken after holding public hearing in concerned States. This would be adopted in all cases referred for inclusion/exclusion in future. Simultaneously, report may be called for from concerned NCSC State Office.

It was brought to notice that practice adopted in case of OBC (by NCBC) is as under:-

- (i) Atleast 3-4 weeks notice is given to concerned State Government.
- (ii) State Government publishes an advertisement in print media atleast two weeks in advance indicating castes/sub-caste details to be consulted.

- (iii) Any body interested can participate in Commission's public hearing.
- (iv) Hearing is generally initiated with a case presentation by a Principal Secretary / Secretary to State Government.

Present reference under consideration may be replied to accordingly to Ministry of SJ&E. **[Action: US (SSW)]**

- (i) **Complaint Monitoring Information System (CMIS)** – Office Order No.12/4/NCSC/2010-C.Cell dated 13.7.2012 (**Annexure-I**) recently issued was perused. It was decided to expedite early implementation. **[Action: C.Cell]**
- (ii) **Website Development and Redesigning thereof.** Presently the work is ongoing. It would take about 4-6 weeks. The Commission was informed that uploading of contents is going on and the website is likely to be ready by August end. **[Action: C.Cell]**
- (iii) **Report of the Sub-Committee:** May be expedited (status at Annexure-II).
- (iv) **Annual Reports for 2010-11 (Part) and 2011-2012:** May be expedited.
- (v) **Biometric Attendance System:** Implementation may be ensured early.
- (vi) **Setting up of New Offices of the Commission:** Necessary information has already been given to Ministry of SJ&E. It needs to be followed up.
- (vii) **Renovation of NCSC office and requirement of additional space for office accommodation at HO:** Renovation of Conference Room has started. Further, a proposal for additional office space is under preparation and will be taken up with Ministry of Urban Development at the earliest. **[Action: General Section]**

(viii)JS proposed that Secretary should be appointed as CVO in the Commission as per Rules of Procedure ( RoP ) which was agreed to by Secretary. Necessary action may be taken in the matter. **[Action: SO (Vigilance)]**
