NOTIFICATION

1. Short title and commencement:-

- (1) These rules may be called the Commission for Scheduled Castes and Scheduled Tribes(Group 'A' post) Recruit-ment Rules, 1986.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and scale of pay:

 The number of post, its classification and the scale of pay attached there to shall be as specified in columns 2 to 4 of the Schedule here to annexed.
- The method of recruitment, age limit and other qualifications:

 The method of recruitment, age limit, qualifications and other matters relating to the said rost shall be as specified i columns 5 to 4 of the said schedule.
- 4. Disqualific tion:-

No person, -

- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax:

Where the Central Government is of the opinion that it is accessary or expedient so to do, it may by order, for reacons to be recorded in writing, and in consultation with

the Union Fublic Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

Lavin:

Noting in these rules thall affect reservation, rolaxation of age limit and other corcessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time
