NOTIFIC ATION

proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the posts of personal assistants and stenographers welfare in the Department of Social Welfare, namely:

- 1. Short title and commencement: (1) These rules may be called the Director General Backward Classes Welfare (Personal Assistants and Stenographers) Recruitment Rules, 1970
- 2. They shall come into force on the date of their publication in the Official Gazette.
- 2. Application: These rules shall apply to the posts a as specified in column 1 of the Schedule hereto annexed.
- 3. Number of posts, their classification and scale of pay.

The number of posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the said Schedule.

4. Method of Recruitment, Age Limit, qualifications etc.

The method of recruitment, age limit qualifications and other matters connected therewith shall be as specified in column 5 to 13 of the Schedule aforesaid.

Provided that the upper age limits specified in column 6 of the said Schedule for direct recruitments may be relaxed in case of candidates belonging to the Scheduled Castes, the Scheduled Tribes and other specialcategories of persons in accordance with the orders issued from time to time by the Central Government.

5. Disqualifications: (a) No person, who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life-time of such spouse, shall be eligible for appointment to any of the said posts; and

(b) no woman, whose marriage is void by reason of the husband having a wife living at the time of such marriage, or such marriage, shall be eligible for appintment to any of the said posts:

Provided that the Central Government may, if satisfied that there are special grounds for so doing, exempt any person from this rule.
