**Subject: Bifurcation of Joint Cadre and assigning of Cadre to Group B and Group C officers & staff – reg.**

Sir,

I am directed to refer to Ministry of Social Justice & Empowerment's letter No.A-42018/53/2009-Estt.I dated 11.09.2017 and subsequent clarifications dated 16.01.2018 and 15.02.2018 on the above mentioned subject and to say that this Commission had vide its letter dated 06.02.2017 sought options from the Group B and Group C officers and staff of joint cadre of National Commission for Scheduled Castes (NCSC) for inclusion in either one of the two new proposed cadres viz. cadre of National Commission for Scheduled Tribes (NCST) under the Ministry of Tribal Affairs and the cadre of NCSC. The options submitted by the Group B & Group C officials of the Joint cadre were duly examined in the Commission. It is recalled here that during December 2004, the erstwhile National Commission for Scheduled Castes and Scheduled Tribes (NCSCST) was bifurcated into two separate Commissions namely, the National Commission for Scheduled Castes (NCSC) and the National Commission for Scheduled Tribes (NCST) w.e.f. 19.02.2004. In pursuance of that bifurcation, the officers and staff of the erstwhile NCSCST were divided in the ratio of 2:1 as decided by the Ministry of Social Justice & Empowerment and the Ministry of Tribal Affairs vide NCSC's order dated 01.12.2004. On that basis and with the approval of competent authority in the Commission, the 24 posts of Group 'B' Gazetted and Non-Gazetted in the Joint Cadre, hitherto under the cadre control of this Commission, are transferred to the administrative control and strength of Ministry of Tribal Affairs (NCST):
