

The successful bidder will be required to remove the material within two working days of acceptance of the tender subject to making full payment by Demand Draft in favour of DDO, NCSC, New Delhi payable at New Delhi. However, the competent authority in this Commission reserves the right to extend the aforesaid date.

The Commission reserves the right to reject any or all quotations completely or partially without assigning any reason. In this respect the decision of this Commission will be final.
