Subject:

Filling up the post of Research Officer in the National Commission for Scheduled Castes by deputation (including short-term contract).

It is proposed to fill up 04 posts of Research Officer(General Central Service, Group 'B' Gazetted, Non-Ministerial) in Level-8 of the pay matrix (Rs.47600-151100) of 7<sup>th</sup>Central Pay Commission [(Pay Band-2 of Rs. 9300-34800+4800 (GP) (pre-revised)] in the National Commission for Scheduled Castes/Ministry of Social Justice & Empowerment in Delhi and Commission's State Offices located in Agartala, Ahmedabad, Thiruvananthapuram, Guwahati, Chennai and Hyderabad by deputation (including short-term contract) initially for a period of one year and likely to be extended up to three years. The eligibility conditions for selection by deputation (including short-term contract) for the said post are given below:-

Officers under the Central Government or State Government or Union territory or Universities of recognized research institution or public sector undertakings or autonomous or statutory organizations:

  - (b) possessing the educational qualification, and experience as under:-
  - (i) Master's Degree of a recognized university or Institution in Social Work or Sociology or Economics or Anthropology or Social Anthropology or applied Anthropology or Statistic or Psychology or Geography or Mathematics (with statistics)
  - (ii) Two years' experience of conducting survey or research in the field of social welfare including analysis of data and preparation of the reports.

Note (I):- the departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation (including short-term contract). Similarly, deputitionists shall not be eligible for consideration for appointment by promotion

Note(2):-Period of deputation (including short-terms contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age-limit for appointment by deputation (including short terms contract) shall be not exceeding fifty-six years as on the closing date of receipt of applications.

- 2. Duties attached to the post of Research Officer are:-
  - (i) Collection, Compilation, analysis and interpretation of data, drafting of reports and any other work.
  - (ii) Supervisory work in planning or development of social welfare organization or in the work relating to the welfare of SCs.
